

LIST OF AUTHORIZED IDENTIFICATION

An elector whose name is not on the List of Electors may be added at the time of voting. The *Elections Act* provides a number of options that enable electors – including those without conventional types of identification - to participate.

Option 1: An elector may vote after producing one piece of identification issued by the Government of Yukon, a Yukon First Nation*, the Government of Canada, or a municipality. The identification must show the elector’s name and current residential or mailing address. Samples appear in Section A (below).

Option 2: An elector may vote after producing two pieces of identification that are satisfactory to the Chief Electoral Officer. Both pieces must show the elector’s name and one must show the elector’s current residential or mailing address. A list of identification authorized for this purpose appears in Section B (below).

<p>ATTESTATIONS OF IDENTITY AND ORDINARY RESIDENCE ARE AVAILABLE FOR ELECTORS WHO MAY BE UNABLE TO PROVIDE OTHER TYPES OF IDENTIFICATION, INCLUDING:</p> <ul style="list-style-type: none"> • Care Centre Electors (issued by an authorized representative of a care centre) • Electors Without a Fixed Address (issued by an authorized representative of a facility that provides accommodation, meals or other services to the elector) • Hospitalized Electors (issued by an authorized representative of a hospital) • Incarcerated Electors (issued by an authorized representative of a correctional institution) • Tenant Electors (issued by an authorized representative of a property manager or owner) 	

Option 3: An elector who is unable to provide authorized identification may vote by appointing a vouching elector whose name appears on the List of Electors for his or her electoral district. A vouching elector is restricted to vouching for one elector.

Option 4: An elector who is unable to provide authorized identification, and does not appoint a vouching elector, may vote after completing a signed declaration that will be administered by the election officer at the polling place. The elector will be asked to declare his or her name and current address, and declare that he or she is eligible to vote.

The same identification requirements apply to electors who vote by Special Ballot, in accordance with Section 104 of the *Elections Act*

*as defined in the *Cooperation in Governance Act*
